

**DISS CEMETERY & GARDENS OF REST/REMEMBRANCE**

**FEES with effect from 12th April 2018**

FEES, PAYMENTS AND SUMS fixed and settled pursuant to the Local Government Act 1972 and the Local Authorities' Cemeteries Order 1974 and 1977.

Diss Parish Resident Fees apply where the person to be interred or the person granted the Exclusive Right of Burial is, or immediately before his/her death (six months minimum) lived in or was an elector of the Parish of Diss. In all other cases, the Non-Resident fees apply.

Former inhabitants who, at time of death, were resident in a retirement home located outside Diss will be treated as inhabitants if they are listed on the current or previous four years Registers of Electors.

**NB:** A new Funeral Fund for parents will shortly be introduced by central government, this will cover the cost of burials for children; local authorities will waive the fees and costs will be met by central government. Charges will be revised accordingly when the bill comes into effect.
